TRADEMARK RELEASE


THIS TRADEMARK RELEASE is made as of this 1st day of May, 2013, by BANK OF MONTREAL, as administrative agent ("Administrative Agent"), in favor of BEST CONVEYORS LLC, a Delaware limited liability company ("Company").

FOR GOOD AND VALUABLE CONSIDERATION, including the satisfaction of all obligations, indebtedness and liabilities of the Company secured by the Trademark Collateral (as defined in the Trademark Security Agreement defined herein) pursuant to the Security Agreement (as defined herein) and the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, the Administrative Agent hereby unconditionally and expressly releases, terminates, and extinguishes its liens on and security interests in the Trademark Collateral, including the trademark registrations listed on Schedule A attached hereto and made a part hereof, which liens and security interests were established under and pursuant to (i) a Security Agreement dated as of May 2, 2011 among Company, the other debtors party thereto and Administrative Agent (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") and (ii) the Trademark Security Agreement dated as of April 2, 2012 by the Company in favor of the Administrative Agent (the "Trademark Security Agreement"), which Trademark Security Agreement was recorded with the United States Patent and Trademark Office at reel number 4750 and frame number 0848.

Administrative Agent hereby consents and agrees to execute and deliver, at the request and cost of Company, such further instruments, documents and release forms as Company may reasonably request to more effectively, release, terminate and extinguish any such liens and security interests upon the Trademark Collateral.
