RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

WHEREAS, pursuant to the Grant of Security Interest, Grantor granted to Secured Party a security interest in and continuing lien on all of Grantor’s right, title and interest in, to and under all United States trademarks and trademark applications of Grantor (collectively, the “**Trademark Collateral**”), all proceeds thereof, and the goodwill of the businesses associated with or symbolized by the Trademark Collateral;

WHEREAS, the Grant of Security Interest was recorded with the United States Patent and Trademark Office on March 20, 2012, Reel/Frame 4740/0192;


WHEREAS, Secured Party now desires to terminate and release its security interest in and lien on the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby terminates, releases, and discharges fully its security interest in and lien on the Trademark Collateral (including without limitation the trademarks listed on Schedule A hereto) as granted pursuant to the Grant of Security Interest, and Secured Party reconveys, transfers, and assigns to Grantor, as applicable, without recourse, representation or warranty of any kind, any rights it may have in the Trademark Collateral pursuant to or in connection with the Grant of Security Interest and any right, title or interest of Secured Party shall hereby cease and become void.
