AFFIDAVIT TO AFFIRM THE RELEASE OF
SECURITY INTEREST IN PATENTS AND TRADEMARKS

This Affidavit to Affirm the Release of Security Interest in Patents and Trademarks (this "Declaration") is effective as of April 22, 2013. Terms used but not defined herein have the meanings given such terms in the Intellectual Property Security Agreement (as defined below).

I, Mark D. Fischer, do hereby declare as follows:

1. I am the Senior Vice President of CCC Acquisition Corp., Warnaco Swimwear Products Inc. and Warnaco U.S., Inc., each a Delaware corporation and located at 501 Seventh Avenue, New York, NY 10018 (each, a "Company").
2. In connection with that certain Intellectual Property Security Agreement dated as of October 6, 2000 (the "Intellectual Property Security Agreement"; capitalized terms used but not defined herein shall have the meanings ascribed to them in the Intellectual Property Security Agreement), each Company granted to State Street Bank and Trust Company ("Bank"), a security interest in and to all of its rights, titles and interests in and to the Patents and Trademarks, including the Patents listed on Schedule I hereto and the Trademarks listed on Schedule II hereto, to secure all of the Obligations (the "Security Interest"), which was recorded with the United States Patent and Trademark Office on October 24, 2000 at reel/frame no. 2172/0067 and reel/frame no. 11213/0905.
3. Due to unknown reasons, a termination and release of the Security Interest was not filed with the United States Patent and Trademark Office in connection with each Company's payment in full of the Obligations.
4. The Security Interest has been terminated, released and discharged, and the Security Interest no longer exists in favor of Bank.

The undersigned, being hereby advised that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, declares that the facts set forth in this Declaration are true to the best of his knowledge; all statements made of his knowledge are true; and all statements made on information and belief are believed to be true.


