QUITCLAIM ASSIGNMENT

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign and transfer to Assignee, all of its right, title and interest, if any, in and to the mark "KOZY KITTEN" ("Mark"), including rights associated with the trademark registration which is described on Exhibit "A" attached hereto and made a part hereof, and all common law trademark rights, stylized word marks and logos generated over time in relation to the use of the Mark, together with any goodwill associated therewith or symbolized thereby. Assignor provides no warranty regarding the registration or validity of the Mark. Assignee shall indemnify, defend and hold harmless Assignor and its agents, officers and directors, from and against any and all suits, actions, legal or administrative proceedings, claims, demands, damages, liabilities, interest, fines, penalties, fees (including reasonable outside counsel legal fees, consultant fees and court fees), costs, and expenses arising after the Effective Date from or in any manner directly or indirectly related to the use of the Mark by Assignee or this Quitclaim Assignment.


Assignor agrees to execute any and all additional documents that may be necessary from time to time to carry out the intent of this Assignment.
