REQUEST TO DISCHARGE NOTICES OF SECURITY INTERESTS OVER INTELLECTUAL
PROPERTY (USPTO)

DATE: April 12, 2013

WHEREAS Capital Sports & Entertainment Inc. ("CSEI") and Capital Sports Properties Inc. (collectively with CSEI, "Capital Sports") are the owners of the United States trade-marks (common law or otherwise) and trade-mark applications listed in Schedule "A" attached hereto (collectively, the "Intellectual Property");

WHEREAS Capital Sports granted security interests (the "Security Agreements") in favour of CIT Financial Ltd. ("CIT") as security for certain obligations of Capital Sports to certain lenders, including, without limitation, those under the credit agreement dated as of December 20, 2006 by and between, *inter alia*, Capital Sports and CIT (as the same was amended, restated, supplemented or otherwise modified up to and including the date hereof, the "Credit Agreement") together with all related agreements, documents and instruments in connection with the Credit Agreement;

WHEREAS under the Security Agreements, Capital Sports granted to CIT security interests on, *inter alia*, the Intellectual Property, including the goodwill and all proceeds thereof;

WHEREAS, *inter alia*, CIT and Capital Sports have agreed to terminate the Security Agreements and release the security over the Intellectual Property pursuant to a payout, release and reconveyance agreement dated on or about the date hereof;

WHEREAS CIT acknowledges and agrees that it has terminated and cancelled the Security Agreements and wishes to advise the United States Patent and Trademark Office of same in respect of the Intellectual Property;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. CIT hereby directs the United States Patent and Trademark Office to immediately remove and discharge all security interests registered against the Intellectual Property.
2. CIT hereby further directs Cassels Brock & Blackwell LLP ("CBB"), or any agents that CBB designates in their sole discretion, to perform all acts required in order to obtain the removal and discharge of all security interests registered against the Intellectual Property from the United States Patent and Trademark Office.






