## RELEASE OF SECURITY INTEREST IN TRADEMARKS

Releases and reassigns to Grantors any and all liens, security interests, right, title and interest of Agent pursuant to the Security Agreement in the trademarks more fully identified in Exhibit A attached hereto, without recourse or representation or warranty, express or implied of any kind;

Agent agrees that, upon the request of the Grantors or any successor in interest or assignee thereof, and at the expense of the Grantors, Agent will execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by the Grantors, or any successor in interest or assignee thereof, to effectuate the release of interests contemplated herein.
