TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of April 25, 2013, is made by Fifth Third Bank, as agent for the Purchasers (together with its successors and assigns, the "Agent").

WHEREAS, Capstone Logistics, LLC, a Delaware limited liability company ("Grantor") has erroneously granted a security interest in certain property to the Agent, including without limitation a security interest in certain trademarks (collectively, the "Trademark Collateral"), pursuant to that certain Trademark Security Agreement dated as of March 18, 2013 (the "Trademark Security Agreement");

WHEREAS, the security interests granted to the Agent was recorded at the United States Patent and Trademark Office as follows: on April 4, 2013 at Reel 4998 and Frame 0174;

WHEREAS, Capstone Logistic Services, L.L.C., a Delaware limited liability company ("Trademark Owner") with an address of P.O. Box 2992, Grand Rapids, MI 49501 is the true and correct owner of the Trademark Collateral identified on Schedule 1 attached hereto;

WHEREAS, the Agent has agreed to terminate and release its security interest in all of the Trademark Collateral identified on Schedule 1, and reassign the same to the Trademark Owner.

NOW, THEREFORE, for valuable consideration, the Agent hereby terminates and releases all mortgages, liens, assignments and security interests granted to the Agent and conveys to the Trademark Owner, without representation, warranty, recourse or undertaking by the Agent, all of its right, title and interest, if any, in and to the following:

1. all of the Trademark Owner's Trademarks referred to on Schedule 1 attached hereto, together with any reissues, continuations or extensions thereof;
2. all goodwill of the business connected with the use of, and symbolized by, each Trademark; and
3. all products and proceeds of the foregoing, including without limitation, any claim by the Trademark Owner against third parties for past, present or future (a) infringement or dilution of any Trademark or (b) injury to the goodwill associated with any Trademark.
