UNITED STATES TRADEMARK

WHEREAS, Shumsky Enterprises, Inc., an Ohio corporation with a place of business at 811 East Fourth Street, Dayton, Ohio 45402 ("Assignor"), is the owner of the HEART PILLOW mark for "protective pillow for post-operative use by heart surgery patients," which was registered with the United States Patent and Trademark Office on November 28, 1995, and assigned U.S. Reg. NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers unto Assignee, its successors and assigns, Assignor's entire right, title and interest in and to the Trademark, including the right to sue for past infringement thereof, together with the goodwill of the business symbolized by and associated with the Trademark.
