**ARTICLES OF ORGANIZATION
OF
SOUTHERN GRAPHIC SYSTEMS, LLC**

The undersigned, serving as the organizer, pursuant to KRS Chapter 275, hereby executes and files the following Articles of Organization for the purpose of forming a Kentucky limited liability company under the Kentucky Limited Liability Company Act to be effective as of 9:30 a.m. on January 1, 2013.

ARTICLE I

NAME

The name of the limited liability company shall be Southern Graphic Systems, LLC (the "Company").

ARTICLE II

CONVERSION; FORMER NAME

The Company is the result of the conversion of Southern Graphic Systems, Inc., a Kentucky corporation (the "Corporation"), into a limited liability company pursuant to KRS 275.376. The former name of the Company was Southern Graphic Systems, Inc.

ARTICLE III

APPROVAL OF CONVERSION

The conversion of the Corporation into the Company pursuant to KRS 271B.12-030 and KRS 275.376 required shareholder approval, which approval was obtained from the shareholders of the Corporation by unanimous written consent in lieu of a meeting on December 26, 2012. The designation, number of outstanding shares, number of votes entitled to be cast by each voting group entitled to vote separately on the plan of conversion of the Corporation, and number of votes of each voting group indisputably represented by unanimous written consent, were as follows:

The total number of undisputed votes cast in favor of the amendment was 16,032 out of 16,032, which was sufficient approval of the conversion in accordance with the Corporation's Articles of Incorporation and Bylaws and the Kentucky Business Corporation Act.

ARTICLE IV

REGISTERED OFFICE AND REGISTERED AGENT

The registered office of the Company shall be located at 626 West Main Street, Suite 500, Louisville, KY 40202, and the registered agent at such office shall be Dave Scheve.

ARTICLE V

PRINCIPAL OFFICE

The mailing address of the principal office of the Company shall be 626 West Main Street, Suite 500, Louisville, KY 40202.

ARTICLE VI


STATEMENT OF MANAGEMENT


