TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made and entered into as of April 29, 2013 ("Effective Date") by and between **SUPERMEDIA LLC**, a Delaware limited liability company, located at 2200 West Airfield Drive, DFW Airport, TX 75261 ("Assignor") and **SUPERMEDIA BRE LLC**, a Delaware limited liability company ("Assignee").

WHEREAS, Supermedia Inc., Dex Media, Inc. (f/k/a NewDex, Inc.), and JP Morgan Chase Bank, N.A. are parties to that certain Loan Agreement, along with the several banks and other financial institutions or entities from time to time party thereto, dated as of December 31, 2009, as amended and restated as of the Effective Date (the "Supermedia Loan Agreement");

WHEREAS, pursuant to the Supermedia Loan Agreement, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, all of Assignor's right, title and interest in and to all of the following owned by Assignor, including those existing on the Effective Date and/or thereafter (the "Marks"): means all current and future (i) trademarks, service marks, trade styles, and logos (including all registrations and recordings thereof and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state thereof or any other country or any political subdivision thereof, or otherwise, and including, without limitation, the trademark registrations and applications for the registration of trademarks set forth on Schedule A) and (ii) trademark rights in any trade names, corporate names, company names, business names, fictitious business names, other source or business identifiers, Internet domain names, subdomain names and social media account or page addresses (but excluding all other rights in the foregoing items in this subsection (ii), including any rights in any registrations or recordings for the foregoing items), and in each case of subsections (i) and (ii), all goodwill associated therewith and all common-law rights related thereto.

NOW, THEREFORE, in consideration of the terms and conditions of the Supermedia Loan Agreement and the mutual covenants contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably sells, assigns, transfers, and conveys to Assignee, and Assignee hereby accepts, all of Assignor's right, title and interest in, to and under the Marks, including, without limitation, all common law rights associated therewith, any registrations and applications of any of the foregoing, any renewals and extensions of any of the foregoing, and all corresponding rights that are or may be secured under the laws of the United States and elsewhere, now or hereafter arising or in effect, together with the goodwill associated therewith, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all rights to all causes of action and remedies related to the Marks and all rights to sue for past, present or future infringement, misappropriation, unfair competition, dilution or other violation of any of the foregoing and all rights to recover damages or lost profits in connection therewith.

Assignor agrees, at the reasonable request and expense of Assignee, to take or cause to be taken all such other actions, including the execution of any and all other instruments in writing, further applications, papers, affidavits, powers of attorney, assignments and other documents, which may reasonably be required or necessary to more effectively secure to, record in the name

of, protect and vest in Assignee and its successors and assigns, the entire right, title and interest in and to the Marks. Assignor hereby requests the United States Commissioner of Patents and Trademarks to record Assignee as the assignee and owner of the Marks. This Assignment shall be governed by and construed in accordance with the laws of the State of New York without giving effect to any choice or conflict of law provision or rule that would cause the application of the laws of any other jurisdiction. This Assignment may be executed in counterparts (and by different parties hereto on different counterparts), including by .pdf, each of which shall constitute an original, but all of which when taken together shall constitute a single contract.


