**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of May 9, 2013, is made by CITIBANK N.A., in its capacity as collateral agent for the Secured Parties (in such capacity, together with its successors and permitted assigns, the "Second Lien Collateral Agent"), pursuant to the Second Lien Guarantee and Collateral Agreement dated as of October 4, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement"). Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed thereto in the Guarantee and Collateral Agreement.

W I T N E S S E T H

WHEREAS, CompuCom Systems, Inc. (the "Grantor") and the Second Lien Collateral Agent are parties to the Guarantee and Collateral Agreement;

WHEREAS, pursuant to the Second Lien Patent Security Agreement, dated October 4, 2012, and recorded with the U.S. Patent and Trademark Office on October 5, 2012 (the "Patent Security Agreement") at Reel/Frame No. 029087/0463, the Grantor pledged and granted to the Second Lien Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in the Patent Collateral (as defined in the Patent Security Agreement);

WHEREAS, pursuant to the Second Lien Trademark Security Agreement, dated October 4, 2012, and recorded with the U.S. Patent and Trademark Office on October 5, 2012 (the "Trademark Security Agreement") at Reel/Frame No. 4874/0984, the Grantor pledged and granted to the Second Lien Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, pursuant to the Second Lien Copyright Security Agreement, dated October 4, 2012, and filed with the U.S. Copyright Office for recordation on October 26, 2012 (the "Copyright Security Agreement"), the Grantor pledged and granted to the Second Lien Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in the Copyright Collateral (as defined in the Copyright Security Agreement);

WHEREAS, the Grantor has requested that the Second Lien Collateral Agent terminate and release its security interest in all right, title and interest in and to the Patent Collateral, Trademark Collateral, and Copyright Collateral and associated goodwill, including those patents, trademarks, and copyrights set forth in Schedule 1.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction in full of all obligations, indebtedness and liabilities secured by the Patent Collateral, Trademark Collateral and Copyright Collateral, the receipt and adequacy of which are hereby acknowledged, the Second Lien Collateral Agent hereby TERMINATES, DISCHARGES and RELEASES, without recourse,


representation or warranty, its security interest in all right, title and interest in and to the Patent Collateral, Trademark Collateral, and Copyright Collateral and associated goodwill, including those patents, trademarks, and copyrights set forth in Schedule 1, and any right, title or interest of the Second Lien Collateral Agent in such Patent Collateral, Trademark Collateral and Copyright Collateral shall hereby cease.

The Second Lien Collateral Agent agrees to provide the Grantor with any information and additional authorization reasonably necessary to effect the release of the Second Lien Collateral Agent's security interest in the Patent Collateral, Trademark Collateral, and Copyright Collateral, including the execution and delivery to the Grantor of any documents reasonably requested by the Grantor to evidence the release of such security interest.
