SECURITY INTEREST TERMINATION

WHEREAS, iParty Retail Stores Corp. and iParty Corp. (each individually, a "Grantor" and collectively, the "Grantors"), granted a security interest to Wells Fargo Bank, National Association (the "Secured Party") in those certain trademarks set forth on Exhibit A hereto (the "Marks"), pursuant to, among other agreements, that certain Intellectual Property Security Agreement dated as of July 1, 2009 (such security interest referred to herein as the "Security Interest");

WHEREAS, the Security Interest was granted to the Secured Party in its capacity as either (i) successor-by-merger to Wells Fargo Retail Finance, L.L.C. or (ii) Wells Fargo Retail Finance, LLC, as assignee of Wells Fargo Retail Finance II, LLC, as applicable;

WHEREAS, the Security Interest was recorded with the United States Patent and Trademark Office on (i) Reel 2531 beginning on Frame 0310, (ii) Reel 2893 beginning on Frame 0185 and (iii) Reel 3467 beginning on Frame 0074; and

WHEREAS, the Security Interest of the Secured Party in the Marks has been terminated.

NOW, THEREFORE, the Secured Party releases its security interest in, and reassigns to each Grantor, any and all interest the Secured Party has, if any, in the Marks and declares as null and void all liens, security interests, and other claims, including any claim of ownership, of the Secured Party with respect to the Marks arising from the Security Interest.
