AND WHEREAS the Assignee is desirous of acquiring the Trade-Marks;


NOW THEREFORE BY THESE PRESENTS WITNESS THAT:

4. The Assignor hereby undertakes to execute and deliver such documents and do such things as may be reasonable requested by the Assignee to give full effect to this Agreement.
5. This Agreement shall enure to the benefit of and be binding upon the parties hereto and their respective successors and permitted assigns.
