TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of May 8, 2013 ("Release"), is made by **SILICON VALLEY BANK**, as Administrative Agent ("Administrative Agent"), in favor of **AVAIL MEDIA HOLDINGS, INC.**, a Delaware corporation, **VUBIQUITY, INC.** (f/k/a Avail Media, Inc.), a Delaware corporation, **AURORAS ENTERTAINMENT, INC.**, a Montana corporation, **BROADSTREAM COMMUNICATIONS, INC.**, a Washington corporation, **VUBIQUITY ENTERTAINMENT CORPORATION** (f/k/a TVN Entertainment Corporation), a Delaware corporation, and **AVAIL-TVN INTERNATIONAL HOLDINGS, INC.**, a Delaware corporation (individually and collectively, jointly and severally, "Grantor").

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement dated as of May 21, 2012 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Guarantee and Collateral Agreement") by and among the Grantor and Administrative Agent, and the Trademark Security Agreement dated as of May 21, 2012 ("Trademark Security Agreement") by and among the Grantor and Administrative Agent, Grantor granted to the Administrative Agent a security interest in all of Grantor's right, title and interest in, to and under the Trademarks; and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on May 22, 2012 at Reel 4784 Frame 0861.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Administrative Agent and Grantor agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Guarantee and Collateral Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Administrative Agent hereby terminates the Trademark Security Agreement, and discharges and releases the lien on and security interest in and to the Patents, including, but not limited to, the foregoing listed on Schedule A attached hereto. Administrative Agent understands and agrees that this Release may be recorded with the USPTO at Grantor's expense.

SECTION 3. Further Assurances. Administrative Agent, at Grantor's expense, hereby agrees to duly execute, and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the Trademarks, Administrative Agent will, at Grantor's expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.

IN WITNESS WHEREOF, the Administrative Agent has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
