THIRD: The name of the limited partnership as set forth in its Certificate of Limited Partnership filed in accordance with subsection B of Section 310.2 of the Oklahoma Revised Uniform Limited Partnership Act is "Sooner Pipe, L.P.";

FOURTH: The conversion of the Company into Sooner Pipe, L.P. has been approved by the Company's board of directors and shareholders in accordance with the provisions of Section 1090.5 of the Act;

FIFTH: This Certificate of Conversion to Limited Partnership shall be effective as of 12:01 a.m. CDT on October 1, 2004; and
