WHEREAS, the Assignor desires to convey, transfer, assign, deliver, and contribute to the Assignee all of its right, title, and interest in and to the Marks;


WHEREAS, the Assignee is a limited liability company registered in and subject to the laws of the State of Michigan and desires to acquire all rights to the Marks; and


WHEREAS, the Assignor agrees to assign the Marks to the Assignee and the Assignee agrees to accept the assignment of the Marks.
