**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), dated as of May 13, 2013, is made by Citicorp North America, Inc., as administrative agent ("Agent"), under that certain Credit Agreement, dated as of July 30, 2004 (as amended, restated, supplemented or otherwise modified from time to time) (the "Credit Agreement") (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

WHEREAS, in connection with the Credit Agreement, and together with all general security agreements and intellectual property security agreements entered into in connection therewith or in connection with prior versions thereof, among LCE Acquisition Corporation, Grupo Cinemex, S.A. de C.V., Cadena Mexicana de Exhibición, S.A. de C.V., LCE Holdco, LLC (the Borrowers), the Lenders and Issuers party thereto and Citicorp North America, Inc., as Administrative Agent, and any other parties thereto, the Lenders made credit extensions to the Borrowers;

WHEREAS, in connection with the Credit Agreement, and pursuant to that certain Trademark Security Agreement, dated as of July 30, 2004, (the "Trademark Security Agreement"), the Grantors (as defined in the Trademark Security Agreement) granted to Agent a security interest in the Trademark Collateral (as defined in the Trademark Security Agreement), including certain Trademarks owned by them and Trademark licenses to which they are a party, and all goodwill of the business connected with the use of, and symbolized by, each Trademark, including Trademarks listed on Annex I attached hereto; and

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office (the "USPTO") on September 24, 2004, and at Reel/Frame 3056/0026 and at Reel/Frame 3050/0781.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself and as agent to each other Lender, hereby terminates, releases and discharges without representation, recourse or warranty whatsoever, all of its security interest in and to all of its right, title and interest in the Trademark Collateral, granted pursuant to the Trademark Security Agreements, and Agent hereby retransfers and reassigns any and all such right, title and interest (if any) that Agent may have in the Trademark Collateral to the applicable Grantor, including all goodwill of the business connected with the use of, and symbolized by, each Trademark. The Agent hereby authorizes and requests that the USPTO record this Release. The Agent shall take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
