RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE dated as of May 10, 2013 (this "Release") is made by Golub Capital LLC (f/k/a Golub Capital Management LLC), a Delaware limited liability company, acting in its capacity as agent (in such capacity, the "Agent") under that certain Trademark Security Agreement, dated as of October 31, 2011 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") by and among ABRA, Inc., a Minnesota corporation (the "Grantor") with an address of 6601 Shingle Creek Parkway, #200, Minneapolis, MN 55430 and the Agent.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on November 1, 2011 at reel 4652, frame 0561, the Grantor granted to the Agent a continuing security interest in all of Grantor's right, title and interest in, to and under its owned or thereafter acquired trademarks, including those set forth on the attached schedule (the "Trademark Collateral");

WHEREAS, the Grantor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Agent in the Released Collateral.
