THIS AGREEMENT is effective as of the 08 day of MAY 2013

BETWEEN:

- (1) **I2G Global (Jersey) Ltd**, a company organised under the laws of Jersey and residing at Nautilus House, La Cour des Casernes, St Helier, JE1 3NH, Jersey (the "**Assignor**"); and
- (2) **Aviate Equities Ltd.**, a company organised under the laws of England and Wales under Company No. 5783789 with its registered office at 40 Argyll Street, London W1F 7EB, United Kingdom (the "**Assignee**").

WHEREAS:


- (A) The Assignor is the proprietor of the trade mark (the "**Mark**"), short particulars of which are set out in the Schedule to this agreement.
- (B) The Assignee wishes to purchase the trade mark from the Assignor.

ASSIGNMENT

1. In consideration of the sum of £1 (receipt of which is hereby acknowledged) the Assignor assigns with full title guarantee and transfers to the Assignee all rights, titles and interests to the Mark together with all rights attaching thereto and the right to sue for past infringements and to retain any damages obtained as a result of such action.
2. This assignment is made with the goodwill attaching to and symbolised by the Mark.
3. The Assignor agrees that it will at the request of the Assignee at all times hereafter do all such acts and execute such documents as may reasonably be necessary or desirable both to secure the vesting in the Assignee of all rights assigned to it in this agreement and to assist in the resolution of any question concerning the Mark.
4. The Assignor confirms that the Assignee is authorised to sign on behalf of the Assignor all forms and documents that are required by the Community Trade Marks Office (OHIM) to record this assignment at that Trade Mark Registry.
5. This agreement is governed by English law and is subject to the non-exclusive jurisdiction of the English Courts.




