RELEASE OF THE TRADEMARK SECURITY INTEREST

THIS RELEASE OF THE TRADEMARK SECURITY INTEREST (this “Release”) is made as of May 14, 2013 (the “Effective Date”) by Wells Fargo Bank, National Association in its capacity as Collateral Agent (as such term is referenced under the Amended and Restated Indenture dated as of August 9, 2011) (in such capacity, the “Collateral Agent”) in favor of Performance Food Group, Inc. (f/k/a Vistar Corporation), a corporation formed under the laws of Colorado (the “Grantor”).

WHEREAS, pursuant to the terms and conditions set forth in that certain Grant of Security Interest in United States Trademarks between the Grantor and the Collateral Agent, dated as of August 9, 2011 (the “Trademark Security Agreement”), the Grantor granted to the Collateral Agent a security interest in and lien on all of such Grantor’s right, title and interest in the Trademarks and all Proceeds therefrom (as such terms are defined in the Trademark Security Agreement) (collectively, “Trademark Collateral”);

WHEREAS, the Trademark Security Agreement was recorded with the Trademarks Division of the U.S. Patent & Trademark Office on June 4, 2012 at Reel/Frame number 4798/0844;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Trademark Security Agreement and hereby irrevocably terminates, cancels, re-pledges, reassigns and releases any and all security interests and liens it has against the Trademark Collateral, including those trademarks and trademark applications listed under Schedule I attached hereto (collectively, the “Trademarks”).

If and to the extent the Collateral Agent has acquired any right, title or interest to any of the Trademarks, it hereby re-assigns and re-transfers such rights, title or interest to the Grantor.

The Collateral Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Release, all at the expense of the Grantor.
