CONFIRMATORY RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS CONFIRMATORY RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of April 4, 2013 ("Effective Date") by Tower Three Capital Partners LLC, a Delaware limited liability company, as successor collateral agent ("Tower Three"), in favor of Tri-anim Health Services, Inc., a California corporation ("Tri-anim").

WHEREAS, pursuant to that certain Trademark Assignment, by and between Facet Technologies, LLC, a Georgia limited liability company ("Facet"), and Tri-anim, dated as of February 1, 2010, Facet assigned its entire right, title and interest in, to and under certain trademark registrations and applications, including the United States trademark applications set forth on Schedule A attached hereto (the "Released Marks"), in each case, together with the goodwill associated therewith, to Tri-anim, which assignment was recorded with the United States Patent and Trademark Office ("USPTO") on April 8, 2010 at Reel 4182, Frame 0531;

WHEREAS, Facet purported to grant to Silver Point Finance, LLC, a Delaware limited liability company ("Silver Point"), a security interest in the Released Marks pursuant to that certain Supplement to the Trademark Security Agreement, dated as of April 23, 2010, as recorded with the USPTO on April 26, 2010 at Reel 4183, Frame 0288;

WHEREAS, the conveyance paragraph of the recordation cover sheet for that certain Corrective Assignment, recorded with the USPTO on May 5, 2010 at Reel 4199, Frame 0830, indicates as follows: "Corrective Assignment to correct the security agreement previously recorded on Reel 004193 Frame 0288. Assignor(s) hereby confirms the security agreement for US application 77/859,466 and releases the security agreement for US applications 77/910071 and 77/882595";

WHEREAS, pursuant to the certain Agency Succession Agreement, dated December 17, 2010 (the "Succession Agreement"), among Silver Point, Tower Three, Facet, Facet Holdings Corp., a Delaware corporation ("Holdings") and the lenders party thereto, Tower Three succeeded Silver Point as collateral agent under that certain Credit and Guaranty Agreement, dated July 26 2006, by and among Facet, Holdings, certain subsidiaries party thereto, as guarantors, the lenders from time to time party thereto, Tower Three (as successor to Silver Point) as administrative agent, security trustee, collateral agent, syndication agent, and lead arranger, Fortress Credit Funding I LP, as co-documentation agent, Dymas Funding Company, LLC, as co-documentation agent and Goldman Sachs Specialty Lending Holdings, inc. II, as co-documentation agent;

WHEREAS, pursuant to that Succession Agreement, Silver Point and Tower Three entered into that certain Trademark Assignment, dated as of January 4, 2011, whereby Silver Point granted security interests in certain trademark registrations and applications, including with respect to the Released Marks, to Tower Three, which assignment was recorded with the USPTO on January 10, 2011 at Reel 4449, Frame 0852; and

WHEREAS, Tri-anim has requested that Tower Three confirm its release of any rights or other interests it may have in the Released Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Tower Three: (i) acknowledges and agrees that it has not, at any point in time, owned any right, title or interest in, to or under the Released Marks; and (ii) hereby terminates, cancels, discharges and releases any and all security interests and all other rights or interests it may have against the Released Marks and shall assign the same (to the extent any such rights or interests exist) to Tri-anim.

Tower Three shall take all further actions, and provide to Tri-anim, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), to the extent reasonably requested by Tri-anim to more fully and effectively effectuate the purposes of this Release.

Tower Three hereby authorizes Tri-anim to make such filing with the USPTO as may be reasonably required to record and evidence the termination, cancellation, and release of the security interests in the Released Marks, as evidenced hereby.

IN WITNESS WHEREOF, Tower Three has caused this Release to be executed by its duly authorized representative as of the Effective Date.
