INTELLECTUAL PROPERTY ASSIGNMENT

In consideration of good and valuable consideration, sufficiency and receipt of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignor hereby irrevocably sells, assigns, grants, transfers and sets over unto Assignee and Assignee's successors and assigns, its entire right, title and interest in and to (a) the services marks and logos listed on Exhibit A attached hereto; (b) domain names listed on Exhibit B attached hereto; (c) together with all US, state and common law rights, registrations or applications; (d) renewals or extensions thereof or applications for such; (e) all goodwill associated therewith; and (f) all benefits, privileges, causes of action and remedies relating to any of the foregoing, whether before or hereafter accrued including, without limitation, the exclusive rights to apply for and maintain all such registrations, renewals and/or extensions; to sue at law or in equity for any past, present or future infringements or other impairment of any of the foregoing, including the right to receive all proceeds and damages therefrom (the "Seller Intellectual Property").
2. Assignor agrees to execute such written instruments, extend such other cooperation and perform such other acts as may be reasonably necessary or advisable to more effectively transfer and assign to and vest in Assignee the Seller Intellectual Property, all at the sole cost and expense of Assignee, including but not limited to, making all required filings with the United States Patent and Trademark Office and any domain name registries; and Assignor hereby irrevocably appoints Assignee and any of its officers as Assignor's attorney in fact to undertake such acts in Assignor's name.
3. This Assignment shall be binding on and inure to the benefit of the parties hereto and their respective successors and assigns.
4. The Exhibits referenced herein and attached hereto are hereby incorporated into this Assignment.
5. This Assignment may be signed in one or more counterparts, each of which shall be deemed an original and together which shall constitute one and the same instrument.
6. All notices, demands, or other communications given under this Assignment shall be sent in writing to the other party.
7. Assignee hereby accepts the foregoing assignment and transfer of the Seller Intellectual Property upon the terms and subject to the conditions contained herein.
