**DECLARATION OF ROBERT H. STALVEY, JR.**

1. My name is Robert H. Stalvey, Jr. I am the Vice President of Ace Electric, Inc. (“Ace Electric”). The information set forth in this declaration is based on my personal knowledge and on documents maintained either in the ordinary course of business by Ace Electric or available on the U.S. Patent and Trademark Office’s website.

2. On April 13, 1993, Ace Electric received Reg. No. 1764906 of the ACE ELECTRIC (and design) service mark. Since that time, Ace Electric has not assigned to any other party any interest in Reg. No. 1764906 or the mark covered by that registration. Nevertheless, in connection with Ace Electric’s preparation to renew Reg. No. 1764906, Ace Electric has become aware that the registrant of record for Reg. No. 1764906 is mistakenly identified as Westco Distribution, Inc. (“Wesco”).

3. It appears from the online assignment information for Reg. No. 1764906 that this mistaken identification has its origin in a security interest recorded against the registration at Reel/Frame 3209/0664 on October 17, 2005 by General Electric Capital Corp. That security interest was subsequently released, but, before the release was recorded at Reel/Frame 4705/0956 on January 27, 2012, Westco recorded a merger document at Reel/Frame 4918/0366, which improperly identifies Westco as the owner of Reg. No. 1764906.


4. Westco subsequently entered into an agreement with Credit Suisse AG, pursuant to which Westco purported to assign a security interest in Reg. No. 1764906 to Credit Suisse AG. That purported security interest was recorded at Reel/Frame 4918/0366 on December 13, 2012.

5. Through its counsel, Ace Electric has requested Westco to make corrective filings in the USPTO, but those filings have not been made.

6. Because Ace Electric has not assigned any rights to Reg. No. 1764906 or to the mark covered by that registration to either Westco or to Credit Suisse AG, Ace Electric remains the owner of the registration and of the mark.

7. The undersigned, being warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. § 1001, and that such willful false statements may jeopardize the validity of the registration, declares that the facts set forth in this application are true; all statements made of his own knowledge are true; and that all statements made on information and belief are believed to be true.
