Pursuant to Title 8, Section 251(c) of the General Corporation Law of the State of Delaware (the "DGCL"), BladeLogic, Inc, the undersigned corporation, has executed this Certificate of Merger and hereby certifies to the following:

FIRST: That the name and state of incorporation of each of the constituent corporations (the "Constituent Corporations") of the merger is as follows:

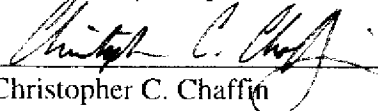
FOURTH: That the Certificate of Incorporation of the Surviving Corporation shall be its Certificate of Incorporation.
