TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment"), dated December 17th, 2012, is by and between Supreme Tournament Boats, LLC, an Oregon limited liability company (the "Assignor"), and Fineline Industries, Inc., a California corporation (the "Assignee").

WHEREAS, Assignor is currently using the marks SUPREME, SKI SUPREME, and SKY SUPREME, WAKE SERIES, SURF SERIES, WORLD CLASS TOWBOATS, V220, V208, V226, V232, V230 AND 220SP for boats and product design services in the field of recreational boat building (the "Trademarks");

WHEREAS, such Trademarks are registered under USPTO registration numbers 3282816 (SUPREME for "Boats"); 3267978 (SKI SUPREME for "Product design services in the field of recreational boat building"); and 3324134 (SKY SUPREME for "Boats").

Assignor desires to assign all right, title and interest in and to the Trademarks and the goodwill associated therewith to Assignee;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are acknowledged, the parties hereby agree as set forth below.

Assignor hereby sells, assigns, transfers and conveys to Assignee the entire right, title, interest in and to the Trademarks in the United States, together with the goodwill of the business connected with and symbolized by the Trademarks (including, without limitation, the right to renew any registrations included in the Trademarks, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademarks, and any priority right that may arise from the Trademarks), the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this sale, assignment, transfer and conveyance not been made.

Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of the registrations and/or applications for registration of the Trademarks to Assignee as assignee of Assignor's entire right, title and interest therein. Assignor agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Trademarks.

This Trademark Assignment Agreement may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts taken together shall constitute one and the same instrument. Each counterpart may be delivered by facsimile transmission, which transmission shall be deemed delivery of an originally executed document.

Assignor represents and warrants that Assignor is not aware of any agreements or contracts limiting in any way Assignor's ability to use and enforce the Trademarks. In addition,

Assignor is not currently aware of any uses of any trademarks or service marks by third parties that would result in a likelihood of confusion to consumers.


