RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Release") is made as of May 13, 2013, by CAPITAL BUSINESS CREDIT LLC ("Capital Business Credit") in favor of ELLERY HOMESTYLES, LLC (the "Grantor").

WHEREAS, the Grantor previously granted to Capital Business Credit a security interest in all of the Grantor's right, title, and interest in and to certain intellectual property (such intellectual property, collectively, the "Pledged IP Collateral"); and

WHEREAS, the Grantor has requested that Capital Business Credit release its security interest in the Pledged IP Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Capital Business Credit hereby agrees as follows:

SECTION 1. Partial Release of Security Interest. Capital Business Credit hereby terminates and releases all of Capital Business Credit's security interest in all of the Grantor's right, title, and interest in and to the following Pledged IP Collateral (the "Released IP Collateral"):

- a. all patents and patent applications set forth in Schedule A hereto (the "Patents");
- b. all trademark and service mark registrations and applications set forth in Schedule B hereto, together, in each case, with the goodwill symbolized thereby (the "Trademarks");
- c. all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, and all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto;
- d. any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and
- e. any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any of the foregoing, except for any and all proceeds received by the Grantors from the transfer of the Released IP Collateral in connection with which this Release is made.

SECTION 2. Recordation. Capital Business Credit hereby authorizes and requests that the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this Release.

SECTION 3. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
