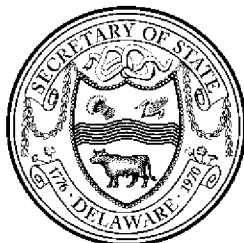

2. The name of the business entity being converted immediately prior to the filing of this Certificate of Conversion is ASC Profiles Inc.

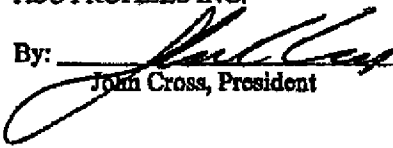
