**ASSIGNMENT AND ASSUMPTION OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS**

*May 13, 2013*

Reference is made to (i) that certain Credit Agreement, dated as of March 26, 2012 (as amended by the First Amendment to Credit Agreement, dated December 10, 2012, and as further amended, amended and restated, supplemented or otherwise modified prior to the date hereof, the "Existing Credit Agreement") by and among ACCO Brands Corporation, a Delaware corporation ("Holdings"), certain Subsidiaries of Holdings from time to time party thereto, the lenders from time to time party thereto (the "Existing Lenders"), Barclays Bank PLC, as administrative agent (in such capacity, the "Existing Administrative Agent"), and Bank of Montreal, as multicurrency administrative agent (in such capacity, the "Existing Multicurrency Administrative Agent"), (ii) that certain U.S. Security Agreement, dated as of April 30, 2012 (as amended, modified, restated and/or supplemented prior to the date hereof, the "Existing Security Agreement"), by and among Holdings, Monaco Spinco Inc., a Delaware Corporation ("SpinCo"), and each of the other assignors undersigned thereto (together with Holdings and SpinCo, and any other Person that may become an assignor thereunder pursuant to Section 10.2 thereof, the "Assignors") and the Existing Administrative Agent, and (iii) those certain Patent Security Agreements (the "Patent Security Agreements"), Trademark Security Agreements (the "Trademark Security Agreements"), and Copyright Security Agreements (the "Copyright Security Agreements"), each dated as of April 30, 2012 or August 9, 2012 and that the Assignors executed in favor of the Existing Administrative Agent (collectively, the "Intellectual Property Security Agreements"). Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Existing Security Agreement.

WHEREAS, pursuant to that certain Second Amendment to the Existing Credit Agreement, dated as of May 13, 2013, by and among Holdings, certain subsidiaries of Holdings party thereto, the Existing Administrative Agent, the Existing Multicurrency Administrative Agent, the New Administrative Agent (as defined therein), the Required Lenders (as defined therein) and the Consenting Lenders (as defined therein) (the "Second Amendment"), the requisite parties to the Existing Credit Agreement and the Existing Security Agreement have agreed to, among other things, (i) amend and restate the Existing Credit Agreement in the form of the Amended and Restated Credit Agreement (as defined in Second Amendment, the "Amended and Restated Credit Agreement") and (ii) amend and restate the Existing Security Agreement in substantially the form of the Amended and Restated U.S. Security Agreement (as defined in the Second Amendment), in each case, effective upon the satisfaction of the conditions precedent set forth in Section III of the Second Amendment;

WHEREAS, pursuant to the Patent Security Agreements, which were recorded with the U.S. Patent and Trademark Office on April 30, 2012 at Reel 028132, Frame 0089, on May 16, 2012 at Reel 028216, Frame 0711, Reel 028217, Frame 0360, and Reel 028218, Frame 0247, and on January 2, 2013 at Reel 029569, Frame 0234 the Assignors pledged and granted to the Existing Administrative Agent for the benefit of the Secured Parties a continuing security interest in all of the right, title and interest of such Assignor in, to and under (a) all United States and foreign patents, certificates of invention, industrial designs or similar industrial property rights, and applications for any of the foregoing, including to: (i) all reissues, divisions, continuations (including continuations-in-part and improvements thereof), extensions, renewals, and reexaminations thereof, (ii) inventions described and claimed therein, (iii) all rights corresponding thereto throughout the world, (iv) all inventions and improvements described therein, (v) all rights to sue for past, present and future infringements or other violations thereof, (vi) all licenses, claims, damages and proceeds of suit arising therefrom and (vii) all Proceeds of the foregoing, including license fees, royalties, income, payments, claims, damages and proceeds of suit now or hereafter due and/or payable with respect thereto ("Patents") of such Assignor, including the registered and applied-for Patents of such Assignor listed on Schedule A attached hereto;

and (b) to the extent not included in clause (a) all Proceeds and products of any and all of the foregoing (collectively, the “Pledged Patent Collateral”);

WHEREAS, pursuant to the Trademark Security Agreements, which were recorded with the U.S. Patent and Trademark Office on April 30, 2012 at Reel 4767, Frame 0409, on May 16, 2012 at Reel 4780, Frame 0943, Reel 4780, Frame 0915, and Reel 4781, Frame 0466, and on November 11, 2012 at Reel 004904, Frame 0315, the Assignors pledged and granted to the Existing Administrative Agent for the benefit of the Secured Parties a continuing security interest in all of the right, title and interest of such Assignor in, to and under (a) all United States and foreign trademarks, trade names, corporate names, company names, business names, fictitious business names, service marks, certification marks, collective marks, trade dress, slogans, logos, other source or business identifiers, designs and general intangibles of a like nature, and with respect to any and all of the foregoing: (i) all registrations and applications for any of the foregoing, (ii) all extensions or renewals of any of the foregoing, (iii) all common-law rights related thereto, (iv) all rights corresponding thereto throughout the world, (v) all of the goodwill of the business connected with the use of and symbolized by the foregoing, (vi) the right to sue for past, present and future infringement, dilution or other violation of any of the foregoing or for any injury to goodwill and (vii) all Proceeds of the foregoing, including license fees, royalties, income, payments, claims, damages and proceeds of suit now or hereafter due and/or payable with respect thereto (“Trademarks”) of such Assignor, including the registered and applied-for Marks of such Assignor listed on Schedule A attached hereto; and (b) to the extent not included in clause (a), all Proceeds and products of any and all of the foregoing (collectively, the “Pledged Trademark Collateral”); and

WHEREAS, pursuant to the Copyright Security Agreements, which were filed with the U.S. Copyright Office on May 18, 2012 the Assignors pledged and granted to the Existing Administrative Agent for the benefit of the Secured Parties a continuing security interest in all of the right, title and interest of such Assignor in, to and under all United States or foreign copyrights, including copyrights in software and databases, and designs (including industrial designs, Protected Designs within the meaning of 17 U.S.C. § 1301 et. seq. and Community designs) and all Mask Works (as defined under 17 U.S.C. 901 of the U.S. Copyright Act), whether registered or not registered and whether published or unpublished, and, with respect to any and all of the foregoing: (i) all registrations and applications therefor (whether in the United States Copyright Office or any foreign equivalent office), (ii) all extensions and renewals thereof, (iii) all rights corresponding thereto throughout the world, (iv) all rights to sue for past, present and future infringements thereof and (v) all Proceeds of the foregoing, including license fees, royalties, income, payments, claims, damages and proceeds of suit now or hereafter due and/or payable with respect thereto (“Copyrights”) of such Assignor, including the registered and applied-for Copyrights of such Assignor listed on Schedule A attached hereto; and (b) to the extent not included in clause (a), all Proceeds and products of any and all of the foregoing (collectively, the “Pledged Copyrights Collateral”); and

WHEREAS, under the Second Amendment, pursuant to Section 9.06 of the Existing Credit Agreement (a) the Borrowers and the Required Lenders (as defined in the Second Amendment) accepted the resignation of Barclays Bank PLC as Administrative Agent, Swing Line Lender and L/C Issuer and the resignation of Bank of Montreal as Multicurrency Administrative Agent (as defined in the Credit Agreement) effective as of May 13, 2013 and (b) the Required Lenders, with the consent of the Borrowers, appointed Bank of America, N.A. (“Bank of America”) to act as the successor “Administrative Agent” under the Amended and Restated Credit Agreement and the other Loan Documents (as defined in the Existing Credit Agreement), (the “Assignment”);

WHEREAS, the Existing Administrative Agent and Bank of America have agreed to execute this Assignment and Assumption to evidence the transfer and assignment of the Existing Administrative Agent’s interest in the Intellectual Property Security Agreements for recordation with the U.S. Patent and Trademark Office and the United States Copyright Office.



NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, each of the Existing Administrative Agent and Bank of America hereby agree as follows:

The effective date of this Assignment and Assumption shall be May 13, 2013 (the "Effective Date").

As of the Effective Date, the Existing Administrative Agent hereby irrevocably assigns to Bank of America, and Bank of America hereby assumes from the Existing Administrative Agent, the Intellectual Property Security Agreements and all rights, remedies, obligations and other interests of the Existing Administrative Agent thereunder.


From and after the Effective Date, (a) each reference in the Intellectual Property Security Agreements to "Administrative Agent" shall be deemed to be a reference to Bank of America, in its capacity as successor Administrative Agent, (b) Bank of America shall have the rights, remedies and obligations of the Existing Administrative Agent under the Intellectual Property Security Agreements and shall be bound by the provisions thereof, and (c) the Existing Administrative Agent shall relinquish its rights and remedies and be released from its obligations under the Intellectual Property Security Agreements except for the rights and protections which survive the assignment set forth herein.

THIS ASSIGNMENT AND ASSUMPTION AND ALL CLAIMS OR CAUSES OF ACTION (WHETHER IN CONTRACT, TORT OR OTHERWISE) THAT MAY BE BASED UPON, ARISE OUT OF OR RELATE IN ANY WAY HERETO OR THE NEGOTIATION, EXECUTION OR PERFORMANCE HEREOF OR THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK WITHOUT REGARD TO PRINCIPLES OF CONFLICTS OF LAW THAT WOULD RESULT IN THE APPLICATION OF ANY LAW OTHER THAN THE LAW OF THE STATE OF NEW YORK. The provisions of Section 11.14 and Section 11.15 of the Amended and Restated Credit Agreement are incorporated by reference herein and made a part hereof.

This Assignment and Assumption may be executed in counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page of this Assignment and Assumption by facsimile or other electronic imaging means shall be effective as delivery of a manually executed counterpart of this Assignment and Assumption.
