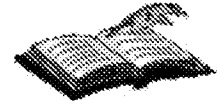

3. Grantor warrants it has the power and authorization to execute this Assignment.


