RECITALS:

- A. CDI Computer Dealers Inc. NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are acknowledged and in accordance with the terms and obligations set forth in the GSA, the Obligor confirms the grant to the Lender under the GSA of a security interest in and to the Intellectual Property.
