TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "**Agreement**"), dated this 22nd day of April, 2013, is being delivered by each of Barnes Group Inc., a Delaware corporation ("**Seller**"), and The Wallace Barnes Company, a Connecticut corporation and a subsidiary of Seller ("**Wallace**" and, together with Seller, "**Assignors**"), to Sid Tool Co., Inc., a New York corporation ("**Assignee**"). Any capitalized terms used herein and not otherwise defined shall have the meanings set forth in the Purchase Agreement (as defined below).

**WHEREAS**, Seller and MSC Industrial Direct Co., Inc. ("**Buyer**") are parties to that certain Asset Purchase Agreement, dated February 22, 2013 (the "**Purchase Agreement**"), pursuant to which, among other things, Seller did agree (and did agree to cause each of its applicable subsidiaries) to sell, convey, assign (but only to the extent assignable) and transfer to Buyer or the applicable member of the Buyer Group all right, title and interest in and to the Transferred Assets (as defined in the Purchase Agreement), including, without limitation, all interest in the trademarks listed on Schedule A attached hereto (the "**Trademarks**");

**WHEREAS**, Assignors are the current owners of the Trademarks as set forth on Schedule A attached hereto; and

**WHEREAS**, Assignee wishes to acquire all of Assignors' right, title and interest in and to the Trademarks, and Assignors wish to assign the same to Assignee.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, effective as of 12:01 a.m. on the Closing Date each Assignor hereby sells, conveys, assigns (but only to the extent assignable) and transfers to Assignee, all of its right, title and interest, including common law rights, in and to the Trademarks, together with the goodwill associated therewith, and the entire business and/or portion thereof to which the Trademarks pertain, and the right to sue and recover for all past, present and future infringements and other violations of the Trademarks, the same to be held and enjoyed by Assignee, its successors and assigns to the same extent that such would have been held and enjoyed by such Assignor had the assignment not been made.


