TRADEMARK ASSIGNMENT

WHEREAS, Sean McAllister is an individual residing at 5801 Edwards Rd. Margate, Florida, 33063 and is the owner of U.S. Trademark application No. 85481203, filed November 28, 2011, for the mark LFTD CLOTHING for clothing, namely, tops, bottoms, t-shirts, hooded sweatshirts, shorts, hats, pants, shirts and a-shirts (hereinafter collectively the "Trademark"); and

NOW, THEREFORE, for \$4,000 and other good and valuable consideration, the receipt of which is hereby acknowledged, Sean McAllister does hereby assign unto Lifted Research Group, Inc., all right, title, and interest in and to the Trademark and application, throughout the world, together with the goodwill of the business symbolized by the Trademark and together with all of that portion of the business associated with the Trademark and the right to sue for infringement of that Trademark, throughout the world.

The parties agree that the \$4,000 will be paid within five business days of receipt by LRG of an original of this Agreement, signed by Sean McAllister before a notary public with the notarization attached, with the payment being sent by Federal Express to the above identified address for Sean McAllister, or as otherwise agreed upon by all Parties to this Agreement.

Sean McAllister further agrees to testify truthfully in any legal proceeding regarding the Trademark, and agrees to sign all lawful papers as requested by Lifted Research Group, Inc., its successors, legal representatives and assigns regarding obtaining and/or maintaining the federal registration of the Trademark.


This Agreement shall be governed by and construed in accordance with the laws of the State of California without regard to its conflict of laws.
