**DECLARATION**

I am authorized to execute this document on behalf of the current owner, Millennium Pharmaceuticals, Inc. ("Owner"), and declare as follows:

1) MillenniumDirect, LLC, a limited liability company organized and existing under the laws of the State of Massachusetts, with an address of 40 Landsdowne Street, Cambridge, Massachusetts 02139, was the owner of the trademark MillenniumDirect, U.S. Reg. No. 3182591 (hereinafter, the "Trademark").

2) MillenniumDirect, LLC was a wholly owned subsidiary of Millennium Pharmaceuticals, Inc., a corporation organized and existing under the laws of the State of Delaware, with an address of 40 Landsdowne Street, Cambridge, Massachusetts 02139. Millennium Pharmaceuticals, Inc. owns the mark MILLENNIUM and multiple registrations therefor for pharmaceuticals and related services.

3) While the MillenniumDirect, LLC subsidiary existed, it owned all right, title and interest in and to the Trademark and the above-named registration therefor. This situation -- in which a company other than Owner owned a mark dominated by the word "Millennium" for a pharmaceutical-related service -- was agreeable to Owner only because of its "unity of control" relationship with MillenniumDirect, LLC.

4) Pursuant to the Operating Agreement of MillenniumDirect, LLC, dated November 11, 2004, the assets of MillenniumDirect, LLC, which include the Trademark and all associated goodwill, would automatically revert to Owner if MillenniumDirect, LLC was dissolved.

5) Effective as of November 28, 2005, the Certificate of Organization of MillenniumDirect, LLC was cancelled.

6) Effective as of November 28, 2005, all right, title and interest in and to the Trademark automatically reverted to the parent, Millennium Pharmaceuticals, Inc., together with the goodwill of the business symbolized by the Trademark and the identified registration therefor, and with all claims arising out of or relating to the use or ownership of the Trademark.

7) Millennium Pharmaceuticals, Inc. is the current owner of the Trademark, the goodwill and the registration therefor.

8) All statements made herein of my own knowledge are true and all statements made on information and belief are believed to be true, and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code and that such willful false statements may jeopardize the validity of the application of any registration resulting therefrom.
