NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Releasor hereby agrees as follows:


1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Copyright Security Agreement.
