TRADEMARK ASSIGNMENT

**THIS AGREEMENT** is dated as of May 22, 2013.

**Parties**

BEVERI NUTRITION, LLC formed and registered in the State of California with company file number 201202010051 whose registered office is at 7421 Chapman Avenue, Garden Grove, California, 92841, United States of America ("Assignor").

MOUNTAIN HIGH ORGANICS, INC. incorporated and registered in the State of Connecticut with company file number 0678289 whose registered business office is at 9 Main Street South, PO Box 1450, New Milford, Connecticut, 06776 ("Assignee").

**Background**

The Assignor is the owner of the trademark Beveri® registered in USA under registration number 3815460 ("the Trademark").

By an asset purchase agreement of even date herewith between the Assignor and the Assignee, the Assignor has agreed to assign all its rights in and to the Trademark to the Assignee on the terms set out below.

**Agreed terms**

**1. Assignment**

In consideration of the sum of US \$10 paid by the Assignee to the Assignor ( receipt of which the Assignor hereby acknowledges), the Assignor hereby assigns all its right, title and interest in and to the Trademark and any common law rights and all the goodwill attaching to the Trademark to Assignee.

**2. Proceedings**

This assignment shall include the right for the Assignee to bring proceedings against any third party in respect of the Trademark (including proceedings against any third party for infringement of the Trademark or for passing off or for otherwise infringing the rights of the Assignor in the Trademark).


**3. Governing law and jurisdiction**

This Agreement shall be governed by and construed in accordance with the laws of the State of Connecticut (other than the choice of law principles thereof). Any action, suit or other proceeding initiated by a party hereto against any other party under or in connection with this Agreement may be brought in any federal or state court in the State of Connecticut, as the party bringing such action, suit or proceeding shall elect, having jurisdiction over the subject matter thereof. The parties hereto hereby submit themselves to the jurisdiction of any such court and agree that service of process on them in any such action, suit or proceeding may be affected by the means by which notices are to be given to it under this Agreement.
