RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST dated as of May 23, 2013 (the "Release") is made by U.S. Bank National Association, in its capacity as Collateral Agent for the Secured Parties ("Collateral Agent") pursuant to that certain Trademark Collateral Agreement dated as of March 27, 2012, by and between Almatica Pharma Inc. ("Grantor") and the Collateral Agent (the "Trademark Collateral Agreement"), as required pursuant to that certain Collateral Agreement as defined therein (the "Collateral Agreement"), in favor of Alvogen, Inc. (as successor of Grantor's right, title and interest in the Trademark Collateral).

WHEREAS, under the terms of the Collateral Agreement, Grantor granted to the Collateral Agent a continuing first-priority lien and security interest in certain Trademark Collateral (as defined in the Trademark Collateral Agreement);



WHEREAS, the Collateral Agent wishes to: (i) release all of its security interest in the Trademark Collateral; (ii) restore all right, title and interest in, to and under the Trademark Collateral to Grantor; and (iii) dissolve any and all liens and encumbrances in respect of the Trademark Collateral under the Collateral Agreement and the Trademark Collateral Agreement; and

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby release, discharge and terminate all of its security interest in all right, title and interest in, to and under the Trademark Collateral, including the trademark registrations and applications identified on Schedule I attached hereto.
