EXECUTION VERSION

RELEASE OF SECURITY INTEREST IN CERTAIN INTELLECTUAL PROPERTY
(TRADEMARKS)

This RELEASE OF SECURITY INTEREST IN CERTAIN INTELLECTUAL PROPERTY (this "Release") is made as of May 14, 2013, by Swedbank AB (PUBL), as Security Agent ("Security Agent") for each of the Finance Parties (as defined in the Facilities Agreement below), in favor of Handinter Alpha, AG ("Grantor"). All capitalized terms used but not otherwise defined herein shall have the meanings ascribed to such terms in the Trademark Security Agreement, dated as of January 31, 2006 (as amended, restated, supplemented or otherwise modified from time to time, the "IP Security Agreement"), between Grantor and the Security Agent.

WHEREAS reference is made to the SEK 2,490,000,000 and EUR 10,000,000 multicurrency term loan and revolving facilities agreement originally dated 23 November 2005, as amended and restated by amendment and restatement agreements dated 26 January 2006, 14 December 2007, 4 June 2008 and 19 December 2012 (the "Facilities Agreement") between, amongst others, Permobil Holding AB, the Existing Borrowers, the Existing Guarantors, the Original Lender, the Arranger, the Facility Agent and the Security Agent (each as defined therein);

WHEREAS, pursuant to the IP Security Agreement, Grantor has granted to the Security Agent, for the benefit of the Finance Parties, a security interest in and to all of such Grantor's right, title and interest in and to the Trademark Collateral, including trademark registration and trademark applications set forth on Schedule A attached hereto (the "Released IP") to secure the prompt and complete payment and performance of the obligations of the Secured Liabilities; and

WHEREAS the IP Security Agreement was recorded on February 13, 2006 with the United States Patent and Trademark Office under Reel and Frame number 3246/0293;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent agrees as follows:

- (a) Security Agent, on behalf of the Finance Parties, hereby relinquishes, releases, discharges and assigns to Grantor its security interest and lien in, to and under the Released IP.
- (b) Security Agent hereby authorizes and requests that the Commissioner for Patents and Trademarks and any other applicable government officer record this Release.
- (c) This Release shall be governed by, and construed in accordance with the law of the State of New York.

IN WITNESS WHEREOF, the Security Agent has caused this RELEASE OF SECURITY INTEREST IN CERTAIN INTELLECTUAL PROPERTY to be duly executed as of the date first written above.
