Corrective Assignment – Affidavit of Rebound Galaxy LLC

The following is a statement of facts and includes an affidavit of the Members of Rebound Galaxy LLC (hereinafter “the LLC”).

1) Prior to November 2010, Mr. Christopher Arsenault was a member of the LLC;

2) In October 2010, Mr. Christopher Arsenault assigned all rights and interest in U.S. Patent Nos. 6,280,367 and 7,488,280 to the LLC. This assignment was recorded in the U.S. Patent office on October 7, 2010 at reel/frame: 025105/0456;

3) On or about November 2010, Mr. Christopher Arsenault was legally removed as a member of the LLC;

4) In 2011 and 2012, the LLC filed tax returns evidencing the above fact that Mr. Christopher Arsenault was not a member of the same in any capacity;

5) In May 2012, Mr. Christopher Arsenault, assigned the rights in the AB SOLO Trademark Registration No. 3,601,694 to the LLC. This assignment was recorded at the U.S. Patent and Trademark office on May 16, 2012 at reel/frame 4781/0066;

6) In December 2012, Mr. Christopher Arsenault executed an assignment of two (2) issued U.S. Patents, one (1) European Patent and one (1) registered Trademark to a new entity, Ab Coaster Inc. Mr. Christopher Arsenault executed this assignment as if here he were a Member of the LLC. The list of this Intellectual property assigned at that time is as follows:

U.S. Patent No.:6,280,367 entitled “Ball Return Apparatus for Exercising Abdominal Muscles”;

U.S. Patent No. 7,488,280 entitled “Method and Apparatus for Abdominal and Upper Body Strength Training”;

European Patent No. 1,890,777 entitled “Method and Apparatus for Abdominal and Upper Body Strength Training”; and

U.S. Trademark Registration No. 3,601,694 for the mark AB SOLO.

7) The patent assignment to Ab Coaster Inc. was recorded at the U.S. Patent and trademark office on December 19, 2012 at reel/frame: 029503/0466; and

8) The Trademark assignment to Ab Coaster Inc. was recorded at the U.S. Patent and Trademark office on December 19, 2012 at reel/frame: 4923/0774.

AFFIDAVIT of the LLC

WHEREAS the members of the LLC hereby state and swear to the following:

- 1) that all of the above facts are true;
- 2) that the 5% member of the LLC, Kelly Robinson was unavailable to execute this document;
- 3) that Mr. Christopher Arsenault was legally removed as a member of the LLC in November 2010;
- 4) that the LLC is an ongoing business and concern and has filed Tax returns in 2011 and 2012, after Mr. Arsenault was removed as a member of the same;
- 5) that at the time of the assignment to Ab Coaster, Inc.,(i.e., December 2012) Mr. Christopher Arsenault was neither a Member, an Agent nor a Representative of the LLC in any legal capacity capable of binding the same;
- 6) that the assignments recorded in the U.S. Patent office for U.S. Patent Nos. 6,280,367 and 7,488,280 (reel/frame: 029503/0466), and U.S. Trademark Registration No. 3,601,694 (reel/frame: 4923/0774), are invalid as they were fraudulently conveyed by Mr. Christopher Arsenault at a time when he had no legal capacity to bind the LLC in any way.
- 7) that all right title and interest in U.S. Patent Nos. 6,280,367 and 7,488,280, European Patent No. 1,890,777 and U.S. Trademark Registration No. 3,601,694 remains in Rebound Galaxy LLC and this corrective assignment has been filed to make the above facts of record and return the ownership of the Intellectual property back to its rightful owner, Rebound Galaxy LLC.
