RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks, dated as of May 23, 2013, is hereby given by Wells Fargo Bank, National Association ("Wells Fargo").

WITNESSETH:

WHEREAS, on May 29, 1990, Wells Fargo and Escalon Packers, Inc. ("Debtor"), a Delaware corporation, entered into a Trademark Mortgage Agreement and a Continuing Security Agreement: Rights to Payment and Inventory pursuant to which the Debtor granted a security interest to Wells Fargo in certain trademarks, service marks, trade names, proprietary labels and logos (collectively, the "Trademarks");

WHEREAS, the Trademark Mortgage Agreement was recorded in the United States Patent and Trademark Office on June 7, 1990, at Reel 0716, Frame 0359;

WHEREAS, in 2001, H.J. Heinz Company, L.P. and its affiliated companies (collectively, "Heinz") acquired Debtor and the Trademarks; and

WHEREAS, Heinz has requested that Wells Fargo release its security interests in the Trademarks as all the obligations of Debtor to Wells Fargo were previously satisfied in full.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged;

Wells Fargo hereby, without representations, warranties or recourse of any kind, releases its security interests in:

- (i) Each trademark and trademark registration listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark and trademark registration; and all proceeds of the foregoing, including, without limitation, any claim by Heinz against third parties for damages for reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark or trademark registration, in each case together with the right to sue for and collect said damages.
