ARTICLES OF AMENDMENT

UNITED CEREBRAL PALSY OF CENTRAL MARYLAND, INC., a Maryland nonstock, non-profit corporation having its principal office in Baltimore County, Maryland (hereinafter referred to as the "Corporation"), hereby certifies to the State Department of Assessments and Taxation of Maryland (the "Department") that:

FIRST: The Charter of the Corporation is hereby amended by deleting therefrom in its entirety Article SECOND and by substituting in lieu thereof the following new Article SECOND:

SECOND: The name of the corporation (which is hereinafter called the "Corporation") is

UNIFIED COMMUNITY CONNECTIONS, INC.

SECOND: The foregoing amendments shall take effect as of April 15, 2013, provided however that such date may not be earlier than the date on which these Articles are filed for record with the Department, nor later than thirty (30) days after the date on which these Articles are filed for record with the Department.

THIRD: At a meeting duly held on September 12, 2012, pursuant to notice duly given or waived, and at which a quorum was present, the Board of Directors of the Corporation duly approved the foregoing amendments. The Corporation is a Maryland nonstock corporation having no members authorized to vote upon any matter.
