TRADEMARK LICENSE AGREEMENT

THIS AGREEMENT is made on the ~~...1...April...2013~~ between the following parties:

TENUTE RAPITALA' S.P.A., located at CONTRADA RAPITALA' 90043 CAMPOREALE (PALERMO), ITALY (the "Licensor") – Chief Executive Officer *Davide MASCALZONI*,
and

GRUPPO ITALIANO VINI S.P.A., located at VILLA BELVEDERE, 37011 CALMASINO (VERONA), ITALY (the "Licensee") – *Charmain Corrado CASOLI*

WHEREAS the Licensor is the proprietor of the following trademarks in USA (thereafter "Licensed Trademarks"):

See Annex "A"

WHEREAS the Licensor TENUTE RAPITALA' S.P.A. is a company organized and existing under the laws of Italy, and the Licensee GRUPPO ITALIANO VINI S.P.A. is a company organized and existing under the laws of Italy.

WHEREAS the Licensor agrees to allow the Licensee to use the Licensed Trademarks pursuant to the terms of this Agreement reached between the two parties.

It is hereby declared as follows:


- 1) The Licensor hereby agrees to permit the Licensee to use the Licensed Trademarks in accordance with the terms set forth in this Agreement in connection with the Licensed Goods/Services, see below:

Trademarks:

A. Trademark Registration

Licensed Goods/Services: The same as those registered in USA., as per annex "A".

- 2) The Licensee shall be permitted to use the Licensed Trademarks on and in relation to the Licensed Goods/Services only so long as the Licensed Goods/Services provided conform to the standards of quality, specifications or directions as may, from time to time, be established by or on behalf of the Licensor. Both the names of the Licensor and the Licensee as well as the origin of services should be marked on the Licensed Goods/Services.
- 3) It is intended that the Licensee shall enjoy the exclusive right of permitted use of the said Licensed Trademarks.
- 4) The Licensee shall not have the right to authorize a third party to use the said Licensed Trademarks in mainland USA, without the permission of the Licensor.
- 5) The Licensee hereby agree that the Licensor may carry out, by its authorized representatives, and is allowed free access to, inspection and control of the quality, specifications or directions of the services provided by the Licensee.
- 6) The Parties hereto shall jointly cooperate in the filing of an application to record this Agreement with the USA Trademark Office.
The beginning dates of the license terms for the Licensed Trademarks are the date on which the Trademark License Agreement is executed.
The contract shall remain in force for ten years, effective as of April 1st, 2013 and shall continue thereafter for an indefinite period of time, with the right of withdrawal of both parties, with a 12 months' notice.
- 7) Should the Licensee use the Licensed Trademarks and commit inconsistencies under the terms and conditions thereof, then this Agreement shall immediately terminate.

- 8) Upon termination of this Agreement for any reason, all rights of the Licensee to the Licensed Trademarks shall be terminated, and the Licensee shall immediately discontinue all use of the Licensed Trademarks.
- 9) The payment due for the use of trademark is determined as follows: 1 (one) Euro per years.

The Parties having noted above now execute this Agreement, as shown below:




