SECURITY INTEREST TERMINATION IN CERTAIN TRADEMARKS


WHEREAS, dELiA*s Group Inc., Alloy Merchandise, LLC and Skate Direct, LLC (collectively, the "Grantors"), granted a security interest to Wells Fargo Retail Finance II, LLC, (the "Secured Party") in those certain trademarks listed on Schedule A hereto (the "Marks"), pursuant to a certain Second Amended and Restated Trademark and Trademark Applications Security Agreement (the "Agreement") which was filed at the United States Patent and Trademark Office on June 8, 2006 and recorded on Reel 3323 and beginning on Frame 0657 and re-recorded to make certain corrections on June 19, 2006 on Reel 3333 and beginning on Frame 0895; and

WHEREAS, the security interests of the Secured Party in the Marks pursuant to the Agreement have been terminated.

NOW, THEREFORE, the Secured Party releases its security interest in, and reassigns to the Grantors, any and all interest it has, if any, in the Marks and declares as null and void all liens, security interests, and other claims, including any claim of ownership, of the Secured Party with respect to the Marks arising from the Agreement. The Secured Party agrees that, upon the request of the Grantors, and at the expense of the Grantors, the Secured Party will execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by the Grantor to effectuate the release of security interest contemplated herein.


