**Termination of Security Interests
In Trademark Rights**

THIS TRADEMARK RELEASE (this "Release") is made as of May 20, 2013 by H.I.G. All American, LLC, a Delaware limited liability company ("Lender").

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement dated October 27, 2009 among Coachmen Industries, Inc., an Indiana corporation, All American Homes, LLC, an Indiana Limited Liability Company, and Mod-U-Kraf Homes, LLC, a Virginia Limited Liability Company (collectively, the "Grantors") and Lender (the "Agreement"), the Grantors have granted to Lender a security interest in the trademark described in Exhibit A attached hereto (the "Trademark").

Notwithstanding anything contained herein, Lender does not in any way release or discharge any party to the above-described Trademark Security Agreement (each a "Party"), and no Party in any way releases Lender from any claim, cause of action, duty, or obligation, of any type whatsoever which is unrelated to the release of the above-described Trademark Security Agreement.

This Release shall be governed by and construed in accordance with the laws of the State of Wisconsin without regard to conflicts of law principles.

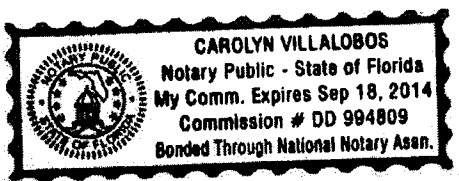
