TRADEMARK ASSIGNMENT

WHEREAS, Corel Corporation, a Canadian corporation having a place of business at 1600 Carling Avenue, Ottawa, Ontario, Canada K1Z 8R7 ("Assignee"), Avid Technology, Inc., a Delaware corporation having a place of business at 75 Network Drive, Burlington, MA 01803 ("Parent"), and Pinnacle Systems, Inc., a California corporation having a place of business at 280 North Bernardo Avenue, Mountain View, California ("Pinnacle" and together with Parent, the "Assignors" and each an "Assignor") have entered into a certain Asset Purchase Agreement dated as of June 21, 2012, pursuant to the terms of which Assignors agreed, and do hereby agree, to assign all right, title and interest in and to certain trademarks, service marks, trade dress, logos, trade names and domain names, including goodwill associated therewith, and applications, registrations and renewals in connection therewith, listed on Schedule A attached hereto and made a part hereof (hereinafter referred to as the "Marks"); and

Each Assignor hereby sells, assigns, transfers and sets over to Assignee, its successors and assigns, all right, title, and interest in and to the Marks together with the goodwill of the business in connection with which the Marks have been used, and rights to sue or make claims for any past, present or future infringement, misappropriation or unauthorized use of any the foregoing, and the rights to all damages, royalties or other payments that are now due or may become due and payable with respect to any of the foregoing.

Assignors hereby request the United States Patent and Trademark Office Commissioner for Trademarks and any other applicable governmental entity or registrar (including any applicable foreign or international office or registrar), to record Assignee as the assignee and owner of the Marks. Assignors hereby authorize and request the officials of all countries in which any of the Marks is now or will in the future be issued to issue to Assignee all of each Assignor's right, title and interest in and to the same, for the sole use and enjoyment of Assignee.

Each Assignor shall execute upon request any other lawful documents reasonably requested by Assignee, its successors or assigns to accomplish the assignments of such rights in United States and in all other countries to Assignee, its successors and assigns.

Neither Assignor makes any representation or warranty to Assignee herein. Any and all representations and warranties made by Assignors to Assignee, including any rights and limitations of the parties with respect thereto, are contained in the Asset Purchase Agreement.

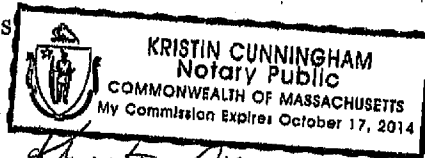
