RELEASE OF SECURITY INTEREST

This Release of Security Interest dated May 29, 2013, is hereby given by JPMorgan Chase Bank, N.A., successor in interest to The Chase Manhattan Bank, a National Bank with an office located at 270 park Avenue, New York, New York 10017 ("Chase").

WITNESSETH:

WHEREAS, on February 20, 1997, Chase, O.R.A. Corporation, a California corporation, (as successor by merger to Delimex Acquisition, Inc.) ("Borrower"), Delimex Holdings, Inc., a Delaware corporation, and several banks and other financial institutions (collectively, the "Lenders") entered into a Credit and Guarantee Agreement pursuant to which the Borrower granted a security interest to Chase for the benefit of the Lenders in certain trademarks, including the trademark registrations listed on Schedule A, attached hereto (collectively, the "Trademarks");

WHEREAS, the Credit and Guarantee Agreement was recorded in the United States Patent and Trademark Office on April 22, 1997, at Reel 1577, Frame 0784;

WHEREAS, in November 2002, H.J. Heinz Company, L.P. and its affiliated companies (collectively, "Heinz") acquired the Trademarks from Borrower; and

WHEREAS, Heinz has requested that Chase release its security interests in the Trademarks and has represented to Chase that all the obligations of Borrower under the Credit and Guarantee Agreement were previously satisfied in full.


NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

Chase hereby releases its security interests in:

- (i) Each trademark registration listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark and trademark registration; and
- (ii) All proceeds of the foregoing, including, without limitation, any claim by Heinz against third parties for damages for reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark or trademark registration, in each case together with the right to sue for and collect said damages.
