NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (SECOND LIEN)

THIS NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (SECOND LIEN) (this "Release"), effective as of May 20, 2013, is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH (f/k/a Credit Suisse, Cayman Islands Branch), as collateral agent (in such capacity, the "Agent"), in favor of INTERMEDIA OUTDOORS, INC. a Delaware corporation (the "Grantor").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of January 31, 2013 (the "Security Agreement"), recorded in the United States Patent and Trademark Office On February 1, 2013 at Reel 4954, Frame 0311, the Grantor granted to the Agent a security interest in the Grantor's right, title and interest in and to the trademark registrations and applications listed on Schedule A hereto (the "Trademarks"), together with all renewals and extensions thereof, all goodwill of the business connected with the use of and symbolized by each such Trademark, and all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof (the "Released Assets"); and

WHEREAS, the Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Released Assets;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees as follows:

1. Release. The Agent hereby relinquishes, releases and discharges its security interest in the Released Assets and all right, title and interest of the Grantor in the Released Assets are hereby reassigned by the Agent to the Grantor, without any representation, recourse or undertaking by Agent.


2. Further Assurances. The Agent hereby agrees, at the Grantor's expense, to execute such instruments and to take such other actions as the Grantor or its legal representatives may reasonably request to terminate the Agent's security interest in the Released Assets.


3. Governing Law. This Notice of Release of Security Interest in Trademarks shall be governed by and construed and interpreted in accordance with the laws of the State of New York.

4. Definitions. Capitalized terms used herein and not defined shall have the respective meaning ascribed to such terms in the Security Agreement.
