TRADEMARK ASSIGNMENT

This Trademark Assignment is between PANLINE USA, INC., a New Jersey corporation, with an office at 251 Union Street, Northvale, New Jersey 07647 (“ASSIGNOR”), and ALEX TOYS, LLC, a Delaware limited liability company (the “Company”), with offices at c/o Propel Equity Partners, 10 Glenville Street, 1st Floor, Greenwich, Connecticut 06831 (“ASSIGNEE”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby mutually acknowledged, ASSIGNOR hereby assigns, transfers and sells to ASSIGNEE, its successors, and assigns, ASSIGNOR’S entire right, title and interest in and to the Marks, the goodwill associated therewith, any portion of ASSIGNOR’S business connected with the Marks, any and all trademark, service mark and trade name registrations and applications therefor, any renewals thereof, all income, royalties, damages, and payments now or hereafter due or payable with respect to the Marks, all causes of action (in law and/or equity) and the right to sue, counterclaim, and recover for past, present, and future infringement,

misappropriation, or dilution of the rights assigned to ASSIGNEE hereunder, and all rights, including the goodwill, corresponding thereto throughout the respective countries where ASSIGNOR holds rights in the Marks.

ASSIGNOR agrees to immediately cease using the Marks and allowing anyone else to use the Marks and further agrees, without further consideration, to cause to be performed such lawful acts and to execute such further documents regarding the rights assigned, transferred and sold herein, as reasonably requested by ASSIGNEE or its successors or assigns.
