The undersigned, being a natural person of at least 18 years of age and acting for the purpose of amending the certificate of incorporation pursuant to Section 805 of the Business Corporation Law of the State of New York (the "NYBCL"), does hereby certify:

1. The name of the corporation is: Cherry Acquisition Corporation (the "Corporation").
2. The date that the certificate of incorporation of the Corporation was filed by the Department of State is April 4, 2013.
3. The amendment effected by this certificate of amendment is as follows:
