ASSIGNMENT OF TRADEMARKS AND TRADEMARK REGISTRATION

This Assignment is made effective on the 29th day of May, 2013, by and among Nassau Broadcasting I, LLC, Nassau Broadcasting II, LLC, Nassau Broadcasting III, LLC and Nassau Broadcasting Partners, L.P., each a debtor and debtor-in-possession under sections 1107 and 1108 of chapter 11 of the Bankruptcy Code under the Cases pending in the Bankruptcy Court (collectively, the "Assignor"), with an address of 619 Alexander Road, Third Floor, Princeton, New Jersey 08540, on the one hand, and Connoisseur Media Acquisitions, LLC (the "Assignee"), with an address of 136 Main Street, Suite 202, Westport Connecticut 06880, on the other hand, with respect to the following facts and circumstances:

WHEREAS, concurrently with the mutual execution and delivery of this Assignment, Assignor and Assignee are consummating the transactions contemplated by the Agreement. Assignor and Assignee are executing and delivering this Assignment in satisfaction of their respective obligations pursuant to Section 4.3 of the Agreement.

WHEREAS, Assignor has adopted the trademarks listed in Appendix A for which it owns common law rights and, as set forth on Appendix A, certain federal registration in the United States Patent and Trademark Office.

WHEREAS, Assignee is desirous of acquiring said trademarks and any and all registrations therefor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Assignor does hereby assign, sell and transfer to Assignee, its successors and assigns, all of its rights, title, and interests in and to said marks, together with the goodwill of the business symbolized by and associated with said trademarks and the trademark registration set forth on Appendix A.






