## RELEASE OF TRADEMARKS

1.

GRANDE COMMUNICATIONS NETWORKS LLC, a limited liability company organized and existing under the laws of the State of Delaware, having an address at 401 Carlson Circle, San Marcos, Texas 78666, Grande Parent LLC and Grande Communications Management Co. (each a "Grantor" and collectively, "Grantors"), entered into a certain Intellectual Property Security Agreement, recorded in the United States Patent and Trademark Office on April 12, 2011, at Reel 4519, Frame 0982 (the "Security Agreement"), and that certain Security Supplement, recorded in the United States Patent and Trademark Office on October 3, 2011, at Reel 4635, Frame 0826 whereby Société Générale, as Collateral Agent for the Secured Parties, as defined in that certain Pledge and Security Agreement, dated as of April 11, 2011, having an address at 1221 Avenue of the Americas, New York, New York 10020 ("Collateral Agent"), was granted a continuing security interest in and lien on all of each Grantor's right, title and interests in, to and under all Intellectual Property Collateral (as defined in the Security Agreement), including the trademarks referred to on Exhibit "A" hereto and incorporated herein by reference and all other Trademarks (as defined in the Security Agreement).

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, on behalf of itself and the Secured Parties, without representation, warranty or recourse of any sort, hereby terminates the Security Agreement and terminates, releases and discharges all its security interest in the Trademarks, together with the goodwill of the business symbolized thereby, and all other security interests granted under the Security Agreement. Any right, title or interest of the Collateral Agent in such Trademarks shall hereby cease and become void.

The Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby at Grantor's expense.
